VEHICLES, BOATS, SNOWMOBILES, ORV's Resident Tribal Members are exempt from both the sales tax and use tax on the following items, regardless of where purchased or used, provided they are purchased for the non-commercial, personal use of the Resident Tribal Member and principally garaged, berthed, or stored within the Agreement Area. - Passenger vehicles including automobiles, pick-up trucks, recreational vehicles and motorcycles - Recreational watercraft - Snowmobiles - Off-road vehicles Joint purchases by a Resident Tribal Member and a non-member spouse are limited to a 3% sales/use tax exemption (half of the 6% tax rate). Use tax must be paid on the fair market value of the vehicle if Tribal member moves out of the Tax Agreement Area after receiving a Resident Tribal Member sales tax exemption.
