

**SAGINAW CHIPPEWA TRIBAL COURT**  
**ADMINISTRATIVE ORDER #14-001**

**FINES AND COSTS FOR CIVIL INFRACTIONS**

The purpose of this Administrative Order is to provide Tribal Court Staff with a guideline to follow for fines and costs involving civil infractions.

A default judgment will be entered and a \$30.00 default fee will be assessed to civil infractions if you do not pay your ticket within 14 days after your final notice for payment.

Effective May 1, 2011, the Saginaw Chippewa Tribal Court began reporting civil infractions (traffic tickets) and convictions of Tribal Code violations in which the punishment exceeds 92 days of incarceration to the Michigan Secretary of State.

This is in accordance with the Law Enforcement Agreement between the Saginaw Chippewa Indian Tribe and the County of Isabella.

This order is effective May 1, 2014.
